<u>Program</u> - Consideration of Application Number 10-0005 for a Resolution authorizing the development of a leveraging program for the Louisiana Department of Health and Hospitals Drinking Water Revolving Loan Fund, including preliminary authorization for the issuance of not exceeding \$200,000,000 of revenue bonds, in one or more series, to represent the initial emission(s) of such revenue bonds; authorizing and approving the form of and publication of the Notice of Sale of Bonds; approving a request for proposals in connection with the selection of a team of underwriters and a trustee for such revenue bonds; making an expression of "official intent" pursuant to Treas.
