approving the sale of the Bonds; ratifying the publication of a Notice of Intention to Sell/Notice of Sale of Bonds and a Notice of Public Hearing; authorizing the execution of other documents in connection therewith; authorizing the officers and trustees of the Authority to do all things necessary to effectuate this resolution; and providing for other matters in connection with the foregoing.

Item 5.        Louisiana Department of Natural Resources Flex-Fund Revolving Loan Program - Consideration of a Resolution supplementing and amending a resolution adopted on April 9, 2013 authorizing a loan through the DNR Flex-Fund Revolving Loan Program to the the Parish of Jefferson, State of Louisiana to provide for a loan to the Consolidated Sewerage District No. 1 of the Parish of Jefferson, State of Louisiana (the “Borrower”) in an amount not exceeding \$2,252,160 and the purchase of a Revenue Bond issued by the Borrower in connection therewith; authorizing the execution of a Loan Agreement and/or a Bond Purchase Agreement between Louisiana Public Facilities Authority and the Borrower by the Chairman, Vice Chairman and Secretary or Assistant Secretary of the Louisiana Public Facilities Authority, and authorizing the execution of related documents, instruments and certificates in connection with said loan and purchase of the Revenue Bond; and providing for other matters in connection with the foregoing.

Item 6.        Louisiana Department of Natural Resources Flex-Fund Revolving Loan Program - Consideration of a Resolution supplementing and amending a resolution adopted on April 9, 2013 authorizing a loan through the DNR Flex-Fund Revolving Loan Program to the Parish of Terrebonne, State of Louisiana (the “Borrower”) in an amount not exceeding \$938,400 and the purchase of a Revenue Bond issued by the Borrower in connection therewith; authorizing the execution of a Bond Purchase Agreement between Louisiana Public Facilities Authority and the Borrower by the Chairman, Vice Chairman and Secretary or Assistant Secretary of the Louisiana Public Facilities Authority, and authorizing the execution of related documents, instruments and certificates in connection with said loan and purchase of the Revenue Bond; and providing for other matters in connection with the foregoing.

Item 7.        Municipal Facilities Revolving Loan Fund Match Program - Consideration of a Motion to ratify the Resolution adopted by the Board of Trustees at its meeting held August 6, 2013, for a Resolution making certain amendments with respect to the Authority's Clean Water State Revolving Fund Match Program, formerly known as the Municipal Facilities Revolving Loan Fund Match Program; authorizing the increase of an additional \$10,000,000 in the maximum amount of such bonds from a maximum of \$25,000,000 to a maximum of \$35,000,000; approving the filing of an application with the Louisiana State Bond Commission; and providing for other matters in connection with the foregoing; this ratification is being made to comply with the rules and regulations of the Authority.
