Municipal Facilities Revolving Loan Fund Match Program - Consideration of a Motion to ratify the Resolution adopted by the Board of Trustees at its meeting held August 6, 2013, for a Resolution making certain amendments with respect to the Authority's Clean Water State Revolving Fund Match Program, formerly known as the Municipal Facilities Revolving Loan Fund Match Program; authorizing the increase of an additional \$10,000,000 in the maximum amount of such bonds from a maximum of \$25,000,000 to a maximum of \$35,000,000; approving the filing of an application with the Louisiana State Bond Commission; and providing for other matters in connection with the foregoing; this ratification is being made to comply with the rules and regulations of the Authority.

Southwest Louisiana Charter Academy Project - Consideration of a Motion to ratify the Resolution adopted by the Board of Trustees at its meeting held September 10, 2013, for a Resolution making certain findings with respect to and authorizing the issuance of not exceeding \$20,000,000 aggregate principal amount of Louisiana Public Facilities Authority Revenue Bonds (Southwest Louisiana Charter Foundation Project) in one or more series, on a taxable or tax-exempt basis; approving the form and authorizing the execution and delivery of a Trust Indenture, a Loan Agreement, and a Contract of Purchase for the Bonds; approving the distribution of a Preliminary Limited Offering Memorandum and a final Limited Offering Memorandum for said Bonds; approving the sale of the Bonds; ratifying the publication of a Notice of Intention to Sell/Notice of Sale of Bonds and a Notice of Public Hearing; authorizing the execution of other documents in connection therewith; authorizing the officers and trustees of the Authority to do all things necessary to effectuate this resolution; and providing for other matters in connection with the foregoing; this ratification is being made to comply with the rules and regulations of the Authority.
