### CERTIFICATION OF INABILITY TO OPERATE DUE TO LACK OF QUORUM

In accordance with Section 2C of Executive Proclamation Number JBE 2020-84, issued by Governor John Bel Edwards on June 25, 2020, this notice shall serve as a certification of the Louisiana Public Facilities Authority's inability to otherwise operate in accordance with the Louisiana Open Meetings Law due to a lack of a quorum as a result of the COVID-19 public health emergency and due to the requirements of said Proclamation.

Pursuant to Section 2C of Proclamation JBE 2020-84, the Louisiana Public Facilities Authority will provide for attendance at its Board of Trustees meeting on July 7, 2020, via a Zoom video conference. Section 2C of Proclamation JBE 2020-84 provides that "all state agencies, boards and commissions, and local political subdivisions of the state shall continue to provide for attendance at essential governmental meetings via teleconference or video conference and such attendance shall be allowed during the pendency of this emergency." An in-person Board meeting would therefore violate this provision and therefore the Louisiana Public Facilities Authority is unable to obtain a quorum (4 of 7 members) in order to conduct business. It is essential for the Louisiana Public Facilities Authority to continue to operate because it must approve the issuance of bonds or other obligations.

Considering the foregoing, and in accordance with Proclamation Number JBE 2020-84, Section 2C, the Louisiana Public Facilities Authority's meeting on Tuesday, July 7, 2020 at 11:00 a.m. will be held via a Zoom video conference and in a manner that allows for participation and input by members of the public, as set forth in this Notice posted on July 1, 2020.
