ACT 302 CERTIFICATION


WHEREAS, pursuant to Act 302 of the 2020 Louisiana Regular legislative Session and La. R.S. 42:17.1 (collectively, the “Act) a public body may conduct, and its members may attend a meeting via “electronic means” as provided in the Act; and

WHEREAS, pursuant to proclamations number 25 JBE 2020, as extended and renewed by 38 JBE 2020, 41 JBE 2020, 43 JBE 2020, 47 JBE 2021, 94 JBE 2021, 137 JBE 2021, 166 JBE 2021, 168 JBE 2021, 203 JBE 2021, 234 JBE 2021, and other statutory and executive authority, the Governor of the State of Louisiana has renewed and extended the declared a state of emergency for the State of Louisiana for the COVID-19 health emergency through January 19, 2022 , and a public in-person meeting of the Louisiana Public Facilities Authority (the “Authority”) on January 11, 2022 would be detrimental to the health, safety, or welfare of the public; and
